Transportation Subcommittee

 Visited Commodity Flow Study observer near local rail lines. Unbalanced traffic after holiday weekend (Labor Day). Was able to get a good number of placards due to long 2mi train stopping near observation location.

• Spills Subcommittee

- o Past spills:
 - 2 unresolved spills: A1 Top Soil is way past 90 days- Prosecutor's Office has engaged with spiller, group had discussed penalties
- o Current period spills: 4 reportable spills
 - Republic Services July 9- first letter to be sent
 - Home Depot July 30- trash compactor spilled into catch basin- submitted report
 - Dutch Maid Logistics Trucking August 27- punctured saddle tank of diesel- spilled into sewer- not past 30 days yet
 - All State Trucking August 30- leaked various fluids into retention pond- not past 30 days yet

CCOEM Report

- o Records Requests- 42
- Sent out two forms to EHS facilities to provide info- facility interview, facility data forms. Use the info
 to update County Hazmat Plan, with map vulnerability zones. Hazmat Plan update due 10/17
- o Submitted LEPC Compliance Report to SERC- due 10/1
- Commodity Flow Study- field surveying began mid Aug. Counting to monitor traffic along: 71, 77, 80, 90, 271, 480, Rt 2, 422, CSX, NS lines. Also reaching out to Port of Cleveland and 3 airports. Due date: 9/28
- Evacuation Annex update- The Final Draft of the County Evacuation Plan has been developed and is in the final review process, including map updates. Feedback from final planning meeting was incorporated into the final draft. Transitioned to the Municipal Evacuation Plan Template and have reached out to 5 communities to gauge interest in being a pilot community.
- o County Prosecutor to review County-LEPC Agreement on behalf of LEPC. Suggested taking out language in Article 2.3. With that language taken out, it allows Prosecutors Office to provide legal service. With that language in, County Law Dept would provide.
- Small group met after last meeting to discuss Population Protection materials. All agreed the training program was out of date and very redundant. Felt that one-page overviews of shelter-in-place and evacuation would suffice.
- Will be giving presentation at upcoming Northeast Ohio Chapter of Hazardous Materials Managers (NEOCHMM) meeting on 9/20
